A meeting of the Table Tennis assembly will be held on 19 August 2002 from 16h00 to 21h00 on the third floor of the Competition Hall, Taipei.

These nations have practiced table tennis in the past but are not included in the current table tennis ranking list and have not participated in a table tennis tournament approved by the table tennis SAEC within the last 30 months.

**WELCOME, REGISTER AND APOLOGIES**

**1. CONFIRMATION OF MINUTES:** of the Assembly held on 23 October 2000 in Sydney, Australia (see attachment A).

2. **ADOPTION OF THE AGENDA:** the Assembly is asked to approve the proposed agenda with or without amendments.
3. **ITTC REPORT:** the Chairperson of the SAEC, Mr. Christian Lillieroos, is asked to give a report from the ITTC for the information of the Assembly (see attachment B).
4. **MOTIONS:** the Assembly is asked to consider and approve the motions circulated with this agenda from the SAEC (see attachment C) and those submitted and circulated from member nations.
5. **FUTURE WORLD CHAMPIONSHIPS BIDS:** the Assembly is asked to note the procedure to be followed when submitting a bid to host the world championships 2006.
6. **ELECTION OF MEMBERS OF THE SAEC 2002 – 2006:** in order to ensure continuity, the Assembly elected some officials in Sydney during the Paralympic Games and some others will be elected in Taipei during the world championships for the period 2002 to 2006. Specifically, the following were elected in Sydney to serve until the next Paralympic Games in 2004:

The SAEC has called for nominations, through the IPC Headquarters, and will circulate the nominations received prior to this Assembly for the positions of:

Vice-Chairperson  
 Selection Officer  
 Medical Officer  
 Technical Officer

The Assembly is asked to note that the voting procedures will be as follows:

- i) the voting be conducted by secret ballot on forms supplied by the Secretary General;

- ii) the Assembly will appoint independent scrutineers to count the votes – independent meaning not being a candidate;
- iii) the nominee polling the highest number of votes will be declared elected;
- iv) should there be an equality of votes, there will be a re-vote for the relevant two nominees to break the tie;
- v) the result will be declared (without revealing the number of votes polled by each candidate) by the chairperson;
- vi) once the election results have been declared, the Assembly will give permission for the ballots to be destroyed.

The Assembly is also asked to note the election of the regional representatives to serve from 2001 to 2005 as follows:

The Assembly is also asked to note that the representative for the African-Middle East region will be elected during the World Championships.
