Situation	<i>History:</i> in relation to sport, the dominance of China has been building since 2000 in Paralympic sport and the nation hosted very successful Olympic and Paralympic Games in 2008. Currently, the CDPF is responsible for sport for persons with a disability, including Deaflympics and Special Olympics, while the CTTA is responsible for table tennis.
	The China Administration of Sports for the Persons with Disabilities, located in the Shunyi District of Beijing, was opened in 2007 after construction was funded by the Government. It includes accommodation, a research building, a multi-sports training gym, a swimming pool, a goalball hall, an athletic and strength training gym, an athletics stadium, a velodrome, 2 football fields (one natural and one artificial) and 2 archery ranges. It was used prior to the Paralympic Games for the Chinese team's last training camp. It is about 30 minutes from the centre of Beijing.
	<i>Weather:</i> for May, it is late spring and for October and December, winter in the context of the northern hemisphere.

Airport	Beijing Capital International Airport which is accessible.
	Distances from some gates to passport control and then to the baggage
	collection points are long (a train helps).
	Team attachés will be available to assist at the airport.
	Should any team arrive from a domestic city, the arrival terminal is separate
	from the international terminal.

Transport	Airport – hotelSchedule: will depend on the arrival of flights.Number of vehicles: a 55 seater (not accessible), a 43 seater (not accessible)are available for non-disabled persons.Accessibility: 4 mini-buses are wheelchair accessible accommodating 20wheelchairs (2 x 4 wheelchairs, 2 x 6 wheelchairs).Time: a car can cover the distance within 25 minutes. A bus is more likelyto take about 40 minutes.
	<ul><li>Hotel - venue <i>Teams and officials:</i> as the hotel is part of the training centre complex, it takes about 4 minutes for a leisurely walk from the hotel to the competition venue. Therefore no transport is necessary.</li><li>Other: can be arranged but at the cost of the team.</li></ul>

Total: the hotel can accommodate 500 persons.

Each room has a television although channels are mainly restricted to Chinese language stations. Each room also has a safe and airconditioning. The entry corridor is about 155cms and the entrance to the bathroom is between 79 and 89 cms depending on the room.

The hotel is a model for wheelchair access including emergency escape ramps. There are 6 elevators which can accommodate on average 3 wheelchairs each.

The hotel also has a laundry facility with about 8 machines in the basement for the use of teams as long as they bring their own washing powder.

Linen will be changed as necessary but probably every 2 or 3 days.

The hotel also has a small shop and 2 automated teller machines in the lobby taking most international cards.




The lobby area with cash machines top left, and before them, the area for internet café



Fencing hall (currently used for storage): 32m x 36m x 8m

Accessibility: the full sports complex is accessible. Competition area: recommend the table tennis hall (provided natural light is excluded) or the powerlifting hall (less natural light). Training area including ball selection: recommend the basketball or rugby hall noting that both have natural light. Changing rooms: due to the number of indoor halls, there are several facilities available, all accessible. Racket testing: a room is available for this. Classification area: there is space available either in a sealed off corridor or in a sport hall.



Possible classification area

*Wheelchair storage:* is available near each sports hall. *Meeting rooms:* in another building will accommodate the team managers' meeting, regional meeting and classification seminar (Fa20 and 50). *Offices:* are available for the TD and referee in various parts of the complex.

*Rest areas:* there is a room which could be used for the umpires. Players could either rest in the many large spaces or return to their rooms.

*Lighting:* in the table tennis hall, there are 4 skylights and windows along 2 sides of the hall which need to be covered. Once this is done, a check needs to be done to ensure adequate lighting is in place (600 lux for Fa20 and 40, 1000 lux for Fa50).

*Media:* space for the media can be provided. *Internet access:* in the TD office and competition venue can be provided.
